I absolutely love trees however, I do not agree with your proposed plan. When I choose trees I think of the work the trees cause eg leaf drop, branches falling and SHADE!

I do not agree with planting big trees close to homes, particularly on the east side of the home, because these trees will block the light to residents.

I live in Butler St and have the park beside my home. I have lived here for 8 years. I have found since moving here that the big trees, in the park close to my home, restrict the light within my home, particularly those trees on the east side of my home. I am having to turn the lights on early in the day, before noon, all through the year. I am often sitting in the dark.

The trees that you are proposing to plant, with shade falling on the homes will affect the growth of plants that residents already have in their gardens, resulting in moss etc.

When trees form a bush/forest close to homes, this increases the security risk. It is an easy place for burglars to hide. Rather than big trees near homes, shrubs would be preferable.

I think the access to the park from Butler St should be more open, not filled with trees. Having the access way blocked by trees may put folk off from entering the park.

I think big trees should be in the centre of the park, away from homes.

The footpath through the park has substantial use by walkers runners and such like and is a safe area with good visibility and just enough lighting. The trees being planted next to the footpath will impact safety by way of reduced visibility and reduced effectiveness of the exiting lighting. The section of pathway from the main park to the Tekapo Place entrance is already quite dark due to the existing trees and the footpath is becoming damaged. This should be a clear indication of what will happen if trees are planted too close to the pathway.

The reason is simple, if any one of these 3 trees were to fall down in a storm it could land on our home (and/or the homes of our neighbours) potentially killing anyone inside the house and causing extensive damage to the house. We had a friend die in exactly this way in 2009 when he was driving down Lower Shotover Road in Dalefield out of Queenstown. A 20m poplar tree fell, landed on his cab and killed him. He was just metres from his home.
In the meantime the trees cause our driveway to be laden with leaves every autumn filling our large bin multiple times.

Man killed by falling tree

A man died metres from his own driveway after his ute was crushed by a falling tree during high winds near Queenstown yesterday.

Sergeant Steve Watt, of Queenstown, said Russell Liggett died after his Toyota Hilux was crushed by a 20m poplar tree about 12.30pm on Lower Shotover Rd.

Several occupants of the cars behind the Hilux saw the tree begin to fall and Mr Liggett trying to brake, he said.

"He applied his brakes but unfortunately he was unable to avoid the tree," Mr Watt said.

Judging by the tyre marks, Mr Liggett braked for at least 3m but the tree still fell directly on top of the driver's cab, crushing it.

He was pronounced dead at the scene but it was at least three hours before the fire service was able to cut open the cab and remove his body.

Police cordoned off the road between Speargrass Flat Rd and Domain Rd for most of yesterday afternoon while the tree and ute were removed.

Mr Liggett was a farmer who lived on Lower Shotover Rd, the same road on which he died, with his wife Cindy. Mrs Liggett did not want to comment to The Southland Times last night.

The MetService issued a strong wind warning for Queenstown yesterday, with gusts reaching 80kmh. The warning said wind could make driving hazardous, toppling trees and powerlines.

Delta systems controller Graeme Johnson said the wind had caused several power failures across the region, including in Arrowtown, Alexandra and Roxburgh. "Generally it's not too bad but the wind has been pretty strong across the whole area," he said.

A tree had fallen on to power lines on Loop Rd yesterday morning, knocking out electricity to parts of Kelvin Heights for about an hour, he said. In the afternoon electricity was temporary out at Millbrook and Lake Hayes, he said.

Mr Watt said Mr Liggett's death follows another tree falling across State Highway 6 near the Crown Range yesterday morning. It blocked traffic until it could be removed.
