## 1 Introduction

Kia ora,

Welles Street has the potential to be one of the most vibrant parts of the central city. With significant, and growing, numbers of people living and working on Welles street (over 114 existing units), in addition to the popularity of the hospitality venues and the preschool in the area, there is a need to improve pedestrian safety and uplift the vibe of the street.

Therefore, Greater Ōtautahi Inc. is submitting on the Welles Street Enliven Places consultation.

Greater Ōtautahi Inc. is an incorporated society whose purpose is to advocate for housing in Ōtautahi Christchurch. Our goals are for the city to have housing in greater numbers, diversity, and quality. The Welles Street project aligns with these goals by showcasing different housing and usage typologies, serving more residents at lower cost. The Welles Street area also shows ways that housing interacts with the public realm.

# 2 Increasing Pedestrian Safety

Improving pedestrian crossings along Welles Street would go a long way to improve pedestrian safety. The area's growing population comes with a corresponding increase in pedestrian traffic; these pedestrians are not currently serviced by any pedestrian crossing, and face inadequate safety measures.

Anecdotally, our observations suggest that many people are forced to cross the street without any proper crossing, dodging cars going quickly, and without being able to see properly past parked cars and work vans. There are also inadequate crossings at both ends of Welles Street that would benefit from curb cutouts (as there is partially on the Manchester Street end of Welles Street).

We request that this project includes adequate pedestrian crossings to make crossing the street safer. This could look like a crossing in the middle of the street (outside Atlas Quarter) or at the Colombo intersection. This could be made using planter boxes and 'temporary' measures and use the parking spots already being removed for minimal cost.

# 3 Trees and Greenery

We are happy to see more trees being planted, but note that they must be maintained well; and we hope that they are mature enough to provide shade during the five-year time period of the plan.

We are worried that due to the temporary nature of the project that the trees and plants will not be given time to mature *in situ* and provide the positive benefits we know that urban greenery can provide such as improved mental health, higher air quality, supporting wildlife, and providing support during heavy rain events.

There should be additional investments made to support greenery in the area on a long term basis. Both trees and shrubs would help the area to feel more lively and break up the amount of concrete and asphalt in the area.

Planting trees that are mature when they are planted would help to provide any boost to the area quicker, and avoid issues with vandalism that have happened elsewhere in the city. This would help to uplift the vibe of the street that is already well served from active hospitality venues and street art.

# 4 Expanding footpaths

Expanding the footpath further with temporary boardwalks and additional curb cuts would also increase the accessibility of the area for people with disability, during peak times, and people with pushchairs.

The steps taken to allow for more seating are welcomed, but should be accompanied by footpath improvements that allow for people to pass safely without being forced out onto the road as currently often happens.

These changes would also act as traffic calming measures in the area as cars have more limited fields of vision and would therefore travel slower, increasing the safety of the area for everyone.

# 5 Reducing the speed limit

In addition to the changes proposed in this project, there also needs to be additional investigation of reducing the speed of Welles Street to 30kmph. Colombo Street street is already 30 kmph when it meets Welles Street, and Manchester's limit is 30 kmph just after it meets Welles Street.

## Introduction

Spokes Canterbury (http://www.spokes.org.nz/) is a local cycling advocacy group with approximately 1,300 followers. Spokes is affiliated with the national Cycling Action Network (CAN – https://can.org.nz/). Spokes is dedicated to including cycling as an everyday form of transport in the greater Christchurch and Canterbury areas. Spokes has a long history of advocacy in this space including writing submissions, presenting to councils, and working collaboratively with others in the active transport space. We focus on the need for safe cycling for those aged 8 to 80. Spokes also supports all forms of active transport, public transport, and has an interest in environmental matters.

## Spokes supports:

- The proposed bike parking near the various venues in Welles St
- Two new seating areas on the southern side and associated landscaping
- The five carparks removed
- The addition of street trees to beautify and calm the space

### Spokes would like to see:

- Sharrows added to the road to encourage cyclists to take the lane in this narrow street.
   The speed limit should be 30km/h but we are aware this is difficult to achieve at the moment.
- Ideally, the permanent treatment would be a shared space with a 10km/h speed limit, trees planted in the ground instead of planters, rain gardens, flush footpath/road level, and nice paving, like Lichfield St between Manchester and Madras Streets
- Even less parking available in the street, with more space for pedestrians and cyclists
- The current walls for the road-side dining are intimidating for less confident cyclists.
- Outside Winnie Bagoes the road surface is rough which does not help. Could you put a smoother surface here?

- The new brown palling fence just down from the Winnie Bagoes has been built too close to the bike stand effectively reducing the available bike parking by one. Like the the bike triangle parking signs.
- More bike parking, the current ones are always full, particularly around Muy Muy and O-Studio where there have been problems with bikes attached to inappropriate places.
- Even more trees
- You could also consider modal filters so there is no way to drive all the way through, or making the street one way
- Did not see any Disability parking on the plan.

## Other

 There is a dangerous transition on Colombo St, from separated cycleway, to on road cycle lane, then an island forcing cyclists to merge with cars who ignore the 30 km/h speed limit. It would be good to get this fixed. (image attached)

### Out of scope, but just a heads up:

There is a dangerous transition on Colombo St heading south towards Welles Street. It starts with a lovely separated cycleway, then transitions to an on-road cycle lane, then an on-road parking space and island, forcing cyclists to merge with motor vehicles (with no sharrow markings), where drivers mostly ignore the 30 km/h speed limit. It would be good to make this safe!

Long Text The spatial arrangement is great. Keeping the parking on the north, adding trees along the whole length and focusing the enhancements on extending out from the hospo on the sunny southern side. As a budget constrained

temporary project, it seems a sensible approach.

Q14 Is there anything about the plans that you'd like to see changed?

The success will be in the detailing and execution. As discussed with Laura last Friday, the new elements need to integrate closely with the character of their specific context.

The footpath seating can pick up the materiality and detailing of the space it extends from, connecting them purposefully - colours, industrial fixings, materials and finishes and even the planting (lush by Kokomo). The business have invested in a high level of design, and this needs respecting and emulating in the furniture, otherwise it will seem an irreverent add on and be undesirable and used less. Desire lines also need considering for each entry point as a balance of cosiness and permeability.

For the trees there needs to sufficient soil for continual growth over the 5 years, which could then be planted permanently on Welles St - all going well! A suggestion is using large (circa 1500mm dia) concrete spun pipes, which are large, cost efficient and can become canvases for local artists. The theme for each artwork could relate to its immediate context or be part of an overall narrative. There's already an abundance of street art on Welles St, so these would add to it's vibrancy and support local artists. It also references the concrete pipes being used by Burger Burger and shurbs could also be planted in them. Larger soil area = larger more successfully growing trees = more urban shade canopy and natural amenity. Tree selection will also be important.

So overall, our studio is stoked about the enhancements and hope something purposeful is created for our quirky and beloved Welles St. Sing out anytime for any further local feedback or collaboration.

This is a first step. Welles Street has moved from being industrial to mixed-use but lacks the supporting street amenities and greenspaces that this should entail. The outcomes of this project will demonstrate that additional funding should be provisioned for permanent improvements.

Clearing the footpaths will make the street more accessible and pedestrian-friendly. Seating will enhance our experience at nearby hospitality businesses. Greenery will enhance the vibe of the street.

#### Is there anything about the plans that you'd like to see changed?

Long Text

We would prefer permanent improvements (including trees planted in the ground). With temporary improvements, we need reassurance that necessary maintenance will be carried out and any issues will be addressed promptly. Welles Street already has a history of gardens and planters on private property becoming untidy, unwatered, and vandalised.

For planters on Atlas Quarter property, Council needs appropriate documentation signed off by the body corporate. We reserve the right to request the planters' removal by Council if they are not properly maintained.

Leaves need to be regularly cleared from around and under the outdoor seating to ensure it doesn't worsen flooding issues on the street.

Council should look into:

- whether police-connected cameras could be installed at the Atlas Quarter entrances on Welles Street and Dundas Street
- whether cabling already exists for such cameras
- how much it would cost for cameras to be installed
- whether a cost-sharing agreement would help.

Bike parks are needed closer to O-Studio, as cycling is popular with their fitness-focused patrons. We have had problems in the past with patrons locking bikes to Atlas Quarter's downpipes.

The speed limit of Welles Street and Dundas Street should urgently be reduced to 30. The current speed limits are unsafe and inconsistent with the speed limit of 30 on Colombo and Manchester Streets.

Council should introduce traffic-calming measures that would make Welles Street more pedestrian-friendly, such as those used on Gloucester Street (or permanent measures). Council should investigate making Welles Street one-way.

Welles Street needs rubbish and recycling bins.

Footpaths should be level and puddle-free. The road should always be easy to cross, even after heavy rain, with no deep puddles that hinder pedestrians.

Pedestrian shortcuts between Welles, St Asaph, Tuam, and Lichfield Streets should be retained to ensure a pedestrian-friendly route between Pak'nSave and the city centre that avoids main roads. We allow the public to cut

through our private property from Dundas Street to Welles Street. It is only fair that we retain the same benefit. Currently it is possible to cut through 25 or 37 Welles Street, but these are private property and both are at risk of being cut off in the future.

We would love temporary closures of Welles Street for family-friendly events like street markets or fairs that would further enliven the neighbourhood.

We are a destination salon and do not rely on walk ins but we are increasingly competing with more suburban salons where there overheads are less and parking is free.

Five carparks may not sound a lot but it is.

We have already lost approximate 4 carparks with the new developments across the road and to add another five lost is just more undue pressure to businesses already working hard to pay their overheads and keep clients coming thorough their doors.

Welles street needs the business they already have, it is a great mix of high quality establishments that add a cool vibe and soul to the area and the last thing this street needs is to be come a ghost town of empty shops and eateries which has been extremely common through out Christchurch.

I would highly recommend reconsidering the car park reduction .
